



Terms and Conditions for East Bistro \$2 off Promotion

1. These Terms and Conditions ("**Terms and Conditions**") for the East Bistro \$2 off promotion ("**Promotion**") are binding on all persons participating in the Promotion organised, conducted and operated by Telecom Equipment Pte Ltd ("**Singtel**") and Angelo's Gastronomy Pte Ltd ("**Merchant**").
2. The Promotion commences on 16 April 2018 and will end on 18 May 2018 (both dates inclusive) ("**Promotion Period**").
