



Terms and Conditions on Promotional fees for Hari Raya Aidilfitri Promotion

The Promotional fees for Indonesia (the “Promotion”) is organised by SingCash Pte Ltd (“Singtel”) and subject to these Terms and Conditions. By participating in the Promotion, all participants shall be deemed to have accepted and agreed to be bound by these Terms and Conditions and all decisions of Singtel, which shall be final and binding in all respects.

1. The Promotion is available from 9-17 June May 2018 (the “Promotion Period”).
2. Under the Promotion, and subject to these Terms and Conditions, eligible Dash Customers (“**Eligible Customers**”) who has made any successful remittance transactions to Indonesia via Singtel Dash from the Eligible Customer’s Singtel Remittance Account during the Promotion Period (“**Qualifying Transactions**”) shall be entitled to the promotional fees for Philippines and Indonesia sas shown below:

3. To be eligible for the Promotion, the Eligible Customer must:
 - a) hold a valid Singtel Remittance Account and Singtel Dash Balance Account, which said accounts must be and remain valid and must not for any reason be terminated and/or suspended, during the Promotion Period;
 - b) comply at all times (including, but not limited to, in making the Qualifying Transactions) with the terms and conditions governing the use of Singtel Remittance Service and Dash Balance, including, but not limited to, the Dash Terms and Conditions and Remittance Terms and Conditions (both of which may be accessed at <https://www.dash.com.sg/terms-and-conditions/>).
 - c) Employees of the Singtel Group of Companies and its appointed advertising, media and any other parties who are directly involved in the organizing and promoting shall not be eligible to participate in the Promotion.
 - d) For the avoidance of doubt, participation in the Promotion is open to individuals only. Corporate or other entities shall not be eligible to participate in the Promotion.

By participating in the Promotion, you consent to Singtel’s collection, holding, storage, use, processing, transfer, disclosure and/or reporting (whether directly or indirectly) to any relevant third party, of your personal data and/or information provided to Singtel, including but not limited to, for the purposes of administering your registration, organizing and promoting the Promotion, or otherwise for purposes relating to the Promotion; and you further consent and acknowledge that your personal data and/or information (i) will also be processed in line with Singtel’s privacy statement available at https://dashprod.s3.amazonaws.com/2016/05/Remittance_Service_TNCs.pdf; and (ii) may be used in accordance with Singtel’s policies, terms and conditions or notices made available by Singtel from time to time.

Singtel reserves the right to, at its sole and absolute discretion, vary, modify and amend any of these Terms and Conditions and/or to suspend, discontinue or terminate the Promotion at any time without prior notification, or liability to any party. In the event of termination of the Promotion, Singtel may at its absolute discretion elect not to award the Fees Rebate in respect of the terminated Promotion.
6. Singtel reserves the right to determine at its sole and absolute discretion all matters arising out of or in connection with the Promotion, including your eligibility to enter and participate in this Promotion and your entitlement to the Fees Rebate. Singtel's determination of all matters relating to this Promotion shall be final and binding and no appeal or objection on any grounds will be entertained.
7. In the event of any inconsistency between these Terms and Conditions and any brochure, marketing or promotion material relating to the Promotion, these Terms and Conditions shall prevail.

By participating in the Promotion, you agree to fully and effectively indemnify, defend and hold harmless Singtel from and against any and all rights, demands, claims, causes of action, losses, damages, costs and expenses whatsoever that you may have, or which may arise, whether in whole or in part, and whether directly or indirectly, due to or arising out of participation in the Promotion. These obligations will continue to survive the expiry or termination of the Promotion.

To the extent permitted by law, Singtel shall not be liable in any way to you or any other person for any losses or damages of any kind, including but not limited to direct, indirect, incidental, consequential, special or punitive damages arising out of or in connection with the Promotion, including without limitation, from any late or non-notification, any error in computing chances, any technical, hardware or software breakdown, malfunction or defects, failed delayed or incorrect transactions, lost or unavailable network connections or any notice that is lost or misdirected.
10. These Terms shall be subject to and construed in accordance with the laws of Singapore and the participants hereby submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
11. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
