



Terms and Conditions for Dash RebateMango Promotion

1. These Terms and Conditions ("**Terms and Conditions**") for the Dash Ezbuy Promotion ("**Promotion**") are binding on all persons participating in the Promotion jointly organised, conducted and operated by Telecom Equipment Pte Ltd ("**Singtel**") and RebateMango ("**Merchant**").
2. The Promotion commences on 13 June 2018 and will end on 31 July 2018 (both dates inclusive) ("**Promotion Period**").
3. Under the Promotion, and subject to these Terms and Conditions, eligible Dash Customers ("**Eligible Customers**") who have successfully registered a new account with the Merchant during the Promotion Period via this link rebatemango.com/dash and make a transaction through Dash via Dash Visa Virtual Account with any RebateMango merchants within the Promotion Period shall be entitled to receive a Merchant Credit of \$6 ("**Merchant Credit**").
4. Merchants featured may subject to change. Merchant reserves the right to amend / append / withdraw terms and conditions without prior notice.
5. This Promotion may be combined with any other on-going promotions offered by Singtel. Unless otherwise stated, this Promotion is not valid with other offers, discounts, rebates, vouchers, privileges or promotions by Merchant.
6. To be eligible for the Merchant Credit:
 - (a) Your Dash Balance must be and remain valid, and must not for any reason be terminated and/or suspended, during the Promotion Period.
 - (b) You must comply at all times with the terms and conditions governing your use of Dash, including, but not limited to, the Dash Terms and Conditions (which may be accessed at <http://www.dash.com.sg/terms>).
7. The Merchant Credit will be credited to your RebateMango account by the Merchant, within 60 days of the qualifying transaction, in accordance with the Merchant's terms and conditions which can be found at <https://www.rebatemango.sg/termsandconditions>.
8. The Merchant Credit is not exchangeable for cash. If the Merchant Credit is not used, the Merchant Credit shall expire and the Eligible Customer shall have no claim whatsoever for any unredeemed Merchant Credit.
9. Notwithstanding any provision in these Terms and Conditions, Singtel, and/or the Merchant, shall be entitled, at Singtel's sole and absolute discretion and without notice to you, to claw-back from you, the Merchant Credit which has been credited to you in connection with these Terms and Conditions (or any part thereof), if such amount has, in Singtel's sole opinion, been wrongfully credited to you for any reason whatsoever.

Singtel reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in its sole absolute discretion and without prior notice to you. In the event of such termination, Singtel may at its absolute discretion elect not to grant you the Merchant Credit in respect of the terminated Promotion.



11. Notwithstanding any other provision of these Terms and Conditions, Singtel has the sole and absolute discretion to determine the eligibility of an Eligible Customer to enter and participate in this Promotion and your entitlement to the Merchant Credit.
12. Singtel's decisions on all matters relating to or in connection with this Promotion and these Terms and Conditions shall be final. No correspondence or claims will be entertained.
13. Singtel is not an agent of Merchant. Goods purchased from or through Merchant ("**Relevant Goods**") shall be subject to such other terms and conditions as may be imposed by Merchant and/or the respective suppliers or merchants for such goods, and you agree to be bound by such terms. In particular, orders that are exchanged, cancelled or refunded will not qualify for the Promotion.

Singtel makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Relevant Goods and assumes no liability or responsibility for the acts or omissions of the merchants and/or suppliers of the Relevant Goods. Any dispute about the value, condition or performance of any of the Relevant Goods is to be resolved directly with the relevant merchants and/or suppliers of the Relevant Goods.

Singtel shall not in any event be liable in any way to you or any person for any loss, liability, damages or expense whatsoever, howsoever arising, in connection with this Promotion (including, but not limited to, that arising from or in connection with any failure or delay by Merchant to credit the Merchant Credit (or any part thereof) to you or any person).

If there is any inconsistency between these Terms and Conditions and such other applicable terms and conditions, these Terms and Conditions shall prevail to the extent of such inconsistency.
