



Terms and Conditions for Dash Mileslife Promotion

1. These Terms and Conditions ("**Terms and Conditions**") for the Dash Mileslife Promotion ("**Promotion**") are binding on all persons participating in the Promotion jointly organised, conducted and operated by Telecom Equipment Pte Ltd ("**Singtel**") and Mileslife ("**Mileslife**").

Notwithstanding any provision in these Terms and Conditions, Singtel shall be entitled, at Singtel's sole and absolute discretion and without notice to you, to claw-back from your Dash Balance, the Discount which has been granted to you in connection with these Terms and Conditions (or any part thereof), if such Discount has, in Singtel's or Mileslife's sole opinion, been wrongfully granted to you for any reason whatsoever.

Singtel reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in its sole absolute discretion and without prior notice to you. In the event of such termination, Singtel may at its absolute discretion elect not to grant you the Discount in respect of the terminated Promotion.
13. Notwithstanding any other provision of these Terms and Conditions, Singtel has the sole and absolute discretion to determine the eligibility of an Eligible Customer to enter and participate in this Promotion and your entitlement to the Discount.

Any dispute about the value, condition or performance of any of the Relevant Goods is to be resolved directly with the relevant Merchants.
17. Singtel shall not in any event be liable in any way to you or any person for any loss, liability, damages or expense whatsoever, howsoever arising, in connection with this Promotion.
