



Terms and Conditions for Dash Run & Raisin Promotion

1. These Terms and Conditions ("**Terms and Conditions**") for the Dash Run & Raisin Promotion ("**Promotion**") are binding on all persons participating in the Promotion jointly organised, conducted and operated by Telecom Equipment Pte Ltd ("**Singtel**") and TOUCH Community Services ("**Merchant**").

In the event of such termination, Singtel may at its absolute discretion elect not to grant you the Discount in respect of the terminated Promotion.
