



Terms and Conditions for Dash Amara Silk Road Mooncakes Promotion

1. These Terms and Conditions ("**Terms and Conditions**") for the Dash Amara Silk Road Mooncakes Promotion ("**Promotion**") are binding on all persons participating in the Promotion organised, conducted and operated by Telecom Equipment Pte Ltd ("**Singtel**") and Amara Hotel Properties Pte Ltd ("**Merchant**").
