



Terms and Conditions for One Championship Event Dash Promotion

These Terms and Conditions for the One Championship event Dash Promotion (“**Promotion**”) are binding on all persons participating in the Promotion organised, jointly conducted and operated by Telecom Equipment Pte Ltd (“**Singtel**”) and Group ONE Holdings Pte Ltd (“**Merchant**”). By participating in the Promotion, all participants shall be deemed to have accepted and agreed to be bound by these Terms and Conditions and all decisions of Singtel, which shall be final and binding in all respects.

1. The Promotion commences on 26th October 2018 and will end on 9th November 2018 (both dates inclusive) (“**Promotion Period**”).
2. Under the Promotion, and subject to these Terms and Conditions, eligible Dash Customers (“**Eligible Customers**”) that satisfy the eligibility criteria in Clause 3, using Dash Visa Virtual Accounts to purchase Cat 2 to Cat 4 ticket(s) on the SportsHub website (<https://www.sportshub.com.sg/ONEChampionship>) for the One Championship event entitled “One: Heart of the Lion”, taking place on 9th November 2018 (“**Event**”) will enjoy:
 - (a) a 25% discount off the purchase price of their tickets (“**Discount**”);
 - (b) a further 10% cashback (“**Cashback**”), calculated based on the final purchase price after the Discount, and capped at Singapore Dollars Five (\$5) per Eligible Customer; and
 - (c) an entry into a lucky draw (“**Lucky Draw**”) with a chance to win either a One: Heart of the Lion poster (“**Poster**”) or a signed copy a One Championship souvenir book (“**Book**”) (referred to singularly as a “**Prize**” and collectively, “**Prizes**”) if the purchase is made during the Lucky Draw Period (defined in Clause 4).

Eligibility

3. To be eligible for the Promotion, the Eligible Customers must:
 - a) hold a valid Singtel Dash Balance Account, which must be and remain valid and must not for any reason be terminated and/or suspended, during the Promotion Period;
 - b) comply at all times (including, but not limited to, in making the Eligible Transaction) with the terms and conditions governing the use of Dash Balance, including, but not limited to, the Dash Terms and Conditions (which may be accessed at <https://www.dash.com.sg/terms-and-conditions/>).
 - c) For the avoidance of doubt, participation in the Promotion is open to individuals only. Corporate or other entities shall not be eligible to participate in the Promotion.

Conduct of the Lucky Draw

4. A lucky draw (the “**Lucky Draw**”) will be conducted in respect of the Lucky Draw Period by Singtel at 31B Exeter Road, Comcentre II, #02-00, Singapore 239733 on the Lucky Draw Date as stated in the table below or on such other date, time and venue as may be determined at the sole and absolute discretion of Singtel.

5. Each Eligible Customer shall be entitled to one (1) Lucky Draw chance as long as he/she uses his/her Dash Visa Virtual Accounts to purchase at least One (1) Cat 2 – Cat 4 ticket to the Event in accordance with the applicable Dash Terms and Conditions (which may be accessed at <http://www.dash.com.sg/terms>).



6. There will be Fifteen (15) winners drawn from the Lucky Draw conducted in respect of the Lucky Draw Period (“**Winners**”) to each win either One (1) of Five (5) One Championship posters or a One (1) of Ten (10) signed One Championship booklets (the “**Prizes**”) which shall be randomly determined by a computerized selection system as stated in Clause 7.
7. Winners will be selected at random through a computerised system in the presence of an authorised personnel of Singtel. Singtel reserves the right to disqualify any Winner if any of these Terms and Conditions are not met, and to select reserve winners to replace any Winner(s) that may be disqualified. Singtel’s decision as to the Winners and reserve Winners of the Lucky Draws shall be final and conclusive. Singtel further reserves the right, at its absolute discretion, to change or substitute the Prizes and/or to increase or reduce the number of Winners for the Lucky Draw Period.
8. All Winners will be notified via SMS or their Singtel Dash registered telephone number on the 8th November 2018.
9. Winner will have to collect their prize in person or by a duly authorised representative at Singtel Dash Booth at the Event located at the SportsHub (the “**Collection Period**”). Winners shall comply with Singtel’s instructions for the purposes of the Lucky Draw. Singtel reserves the right to request for the Winners’ proof of eligibility, identity and/or otherwise for the purposes of verifying the Winner’s claim to the Prize at the time of Prize collection. The Winner must present his/her NRIC or such other identification papers as may be acceptable to Singtel. Where the Prize will be collected by a duly authorised representative of the Winner, the representative must present his/her NRIC or such other identification papers as may be acceptable to Singtel, a copy of the Winner’s NRIC or such other identification papers as may be acceptable to Singtel and the letter of authorisation duly signed by the Winner in such form as may be acceptable to Singtel.
10. Any Prize which is not claimed in accordance with the provisions of these Terms and Conditions within the Collection Period will be forfeited at the sole and absolute discretion of Singtel, and the Winner shall not be entitled to any compensation for the same.
11. All Prizes won or accepted shall be given on an “as-is” basis and are non-transferable, non-assignable, non-exchangeable and non-redeemable for cash and/or any other items. No payment or compensation whether in cash, credit or kind shall be made for any uncollected, lost, misplaced, defaced, stolen or damaged Prize(s).
12. Singtel makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Prizes and assumes no liability or responsibility for the acts or omissions of the merchants and/or suppliers of the Prizes or any non-performance or defects in the Prizes. Any dispute about the value, condition or performance of the Prizes is to be resolved directly with the relevant merchants and/or suppliers of the Prizes.
13. Singtel reserves the right to disqualify any one or more of the Winners following Singtel’s announcement at the Lucky Draw, if
 - a) the Winners are determined, in Singtel’s sole discretion, to be ineligible for any reason whatsoever,
 - b) at any time, Singtel, at its sole and absolute discretion, suspects any fraud in relation to, and/or misuse of, the Winner’s Dash Balance Account; or



- c) the phone number which is registered in respect of the Winner's Dash Balance Account is for any reason changed (whether by the Winner or any other person, with or without the consent or knowledge of the Winner) during the Lucky Draw Period or at any time before the collection of the Prize by the Winner in accordance with these Terms and Conditions.
14. By accepting the Prize, the Winner agrees that Singtel may use the Winner's name, addresses, personal details, photographs or any likeness for advertising and promotional purposes without further consideration. However, Singtel is under no obligation, except when required by law, to disclose the identity of the Winners or to publish the same for any reason at any point of time.

10% Cashback

15. The Cashback is computed based on 2 decimal places without any rounding and will be credited to your Dash Balance within the next Business Day of the purchase. For the purposes of these Terms and Conditions, "**Business Day**" means any day other than a Saturday, Sunday or gazetted public holiday in Singapore.
16. The Cashback is limited to the first 1000 redemptions. Except for any cashback payable under the Dash First Use Cashback Promotion, the Cashback shall be inclusive of all cashbacks, if any, payable in respect of the qualifying Dash payment transactions under any other promotions organised by Singtel, unless otherwise stated.
17. The Cashback and Discount are not exchangeable for cash.
18. Notwithstanding any provision in these Terms and Conditions:
- a) Singtel shall not be required to credit the Cashback or any part thereof to your Dash Balance in connection with these Terms and Conditions, if:
- i. at any time Singtel, at its sole and absolute discretion, suspects any fraud in relation to, and/or misuse of your Dash Balance (whether by you or any other person, with or without your knowledge);
 - ii. your Dash Balance and/or your access to or use of Dash is for any reason terminated and/or suspended during the period from the commencement of the Promotion Period to the date on which Singtel credits your Dash Balance with the Cashback pursuant to these Terms and Conditions (both dates inclusive) ("**Relevant Period**");
 - iii. your Dash Balance following the credit of the Cashback will exceed the wallet limit of \$999 under the Dash Terms and Conditions;
 - iv. the Promotion is terminated in accordance with these Terms and Conditions at any time during the Relevant Period; and/or
 - v. the phone number which is registered in respect of your Dash Balance is for any reason changed (whether by you or any other person, with or without your knowledge) during the Relevant Period.
- b) Singtel shall be entitled, at Singtel's sole and absolute discretion and without notice to you, to claw-back from your Dash Balance, the Discount and Cashback which has been credited to your Dash Balance in connection with these Terms and Conditions (or any part thereof), if such amount has, in Singtel's sole opinion, been wrongfully credited to you for any reason whatsoever



General

- c) This Promotion may not be combined with any other on-going promotions offered by the Merchant unless otherwise stated
- d) By participating in the Promotion and/or the Lucky Draw, the participants consent to Singtel's collection, holding, storage, use, processing, transfer, disclosure and/or reporting (whether directly or indirectly) to any relevant third party, of the participants' personal data and/or information provided to Singtel, including but not limited to, for the purposes of administering the participants' registration, organizing and promoting the Promotion and/or Lucky Draw, or otherwise for purposes relating to the Promotion; and the participants further consent and acknowledge that the participants' personal data and/or information (i) will also be processed in line with Singtel's privacy statement available at <http://www.dash.com.sg/terms>; and (ii) may be used in accordance with Singtel's policies, terms and conditions or notices made available by Singtel from time to time.
- e) Singtel reserves the right to, at its sole and absolute discretion, vary, modify and amend any of these Terms and Conditions and/or to suspend, discontinue or terminate the Promotion/Lucky Draw at any time without prior notification, or liability to any party. - f) Singtel reserves the right to determine at its sole and absolute discretion all matters arising out of or in connection with the Promotion and/or Lucky Draw, including the participants' eligibility and the applicable criteria. Singtel's determination of all matters relating to this Promotion and/or Lucky Draw shall be final and binding and no appeal or objection on any grounds will be entertained.
- g) In the event of any inconsistency between these Terms and Conditions and any brochure, marketing or promotion material relating to the Promotion, these Terms and Conditions shall prevail.
- h) By participating in the Promotion and/or the Lucky Draw, each participant agrees to fully and effectively indemnify, defend and hold harmless Singtel from and against any and all rights, demands, claims, causes of action, losses, damages, costs and expenses whatsoever that the participant may have, or which may arise, whether in whole or in part, and whether directly or indirectly, due to or arising out of participation in the Promotion and/or the Lucky Draw. These obligations will continue to survive the expiry or termination of the Promotion and/or the Lucky Draw.
- i) To the extent permitted by law, Singtel shall not be liable in any way to any participant or any other person for any losses or damages of any kind, including but not limited to direct, indirect, incidental, consequential, special or punitive damages arising out of or in connection with the Promotion and/or Lucky Draw, including without limitation, from any late or non-notification, any error in computing chances, any technical, hardware or software breakdown, malfunction or defects, failed delayed or incorrect transactions, lost or unavailable network connections or any notice that is lost or misdirected.
- j) Singtel is not an agent of the Merchant. The goods and/or services purchased or obtained from the Merchant shall be subject to such other terms and conditions as may be imposed by the Merchant, and you agree to be bound by such terms.
- k) Singtel makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the goods and/or services supplied by the Merchant and assumes no liability or responsibility for the acts or omissions of the Merchant. Any dispute about the value, condition



or performance of any of such goods and/or services is to be resolved directly with the Merchant.

- l) These Terms shall be subject to and construed in accordance with the laws of Singapore and the participants hereby submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
- m) A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
