



## Terms and Conditions for “Singtel Prepaid Bonus Talktime/IDD + Free Incoming Calls + 1GB Local Data with Top Up via Dash” Promotion

1. These Terms and Conditions for the Singtel Prepaid Bonus Talktime/IDD + Free Incoming Calls + 1GB Local Data with Top Up via Dash promotion (“Promotion”) are binding on all persons participating in the Promotion organised, conducted and operated by Telecom Equipment Pte Ltd (“Singtel”).
2. The Promotion commences on 20 September 2018 and will end on 30 November 2018 (both dates inclusive) (“Promotion Period”).
3. Under the Promotion, and subject to these Terms and Conditions, eligible Dash Customers (“Eligible Customers”) shall be entitled to receive a 30% bonus talktime/IDD + free incoming calls to their Singtel Prepaid account (“Top Up Bonus”) for every successful Singtel Prepaid Top Up transactions of at least \$10 per transaction made via the Singtel Dash app during the Promotion Period (“Eligible Transactions”).
4. In addition, Eligible Customers shall also be entitled to receive one-time free 1GB local data (valid for 3 days) on their Singtel Prepaid account (“Free 1GB”) in respect of the first (and only the first) Eligible Transaction of each Singtel Prepaid account under the Promotion during the Promotion Period.
5. To be eligible for the Top Up Bonus and/or Free 1GB:
  - a. Your Dash Account and Singtel Prepaid account must be and remain valid, and must not for any reason be terminated and/or suspended, during the Promotion Period.
  - b. You must comply at all times with the terms and conditions governing your use of Dash, including, but not limited to, the Dash Terms and Conditions and Terms and Conditions for Dash Visa Virtual Account (which may be accessed at <http://www.dash.com.sg/terms>).
6. For avoidance of doubt, the Top Up Bonus and/or Free 1GB is/are awarded to the eligible Singtel Prepaid account which received the top up under the Eligible Transactions (“Beneficiary Singtel Prepaid Account”), which may or may not be the same as the Singtel Prepaid account registered under the Dash account making the Eligible Transaction.
7. This Promotion may not be combined with any other on-going promotions offered by Singtel unless otherwise stated.
8. Singtel reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in its sole absolute discretion and without prior notice to you. In the event of such termination, Singtel may at its absolute discretion elect not to award the Top Up Bonus and/or Free 1GB in respect of the terminated Promotion.
9. Notwithstanding any other provision of these Terms and Conditions, Singtel has the sole and absolute discretion to determine the eligibility of an Eligible Customer to enter and participate in this Promotion and your entitlement to the Top Up Bonus and/or Free 1GB.



10. Singtel's decisions on all matters relating to or in connection with this Promotion and these Terms and Conditions shall be final. No correspondence or claims will be entertained.
11. Singtel shall not in any event be liable in any way to you or any person for any loss, liability, damages or expense whatsoever, howsoever arising, in connection with this Promotion (including, but not limited to, that arising from or in connection with any failure or delay by Singtel to award the Top UP Bonus and/or Free 1GB to you or any person).
