



Terms and Conditions for Dash Morganfield's Promotion

1. These Terms and Conditions ("**Terms and Conditions**") for the Dash Morganfield's Promotion ("**Promotion**") are binding on all persons participating in the Promotion jointly organised, conducted and operated by Telecom Equipment Pte Ltd ("**Singtel**") and MFSG Orchard Central Pte Ltd ("**Merchant**").
2. The Promotion commences on 3 January 2019 and will end on 31 January 2019 (both dates inclusive) ("**Promotion Period**").
3. Under the Promotion, and subject to these Terms and Conditions, eligible Dash customers ("**Eligible Customers**") shall be entitled to purchase any set meals (U.P. \$12.90 to \$27.90) from Morganfield's ("**Morganfield's Promo**") and enjoy \$5 off their set meals during the Promotion Period, only available at Morganfield's Orchard Central (#11-03/04), subject to availability. Limited to first 1000 redemptions, each Dash account is eligible to redeem the \$5 off a set meal once per transaction.
4. Payment for the set meals and all Promotional Items shall be made via Dash (including through Dash Visa Virtual Account), in accordance with the applicable Dash Terms and Conditions and Terms and Conditions for Dash Visa Virtual Account (which may be accessed at <http://www.dash.com.sg/terms>).
5. Promotional Items are non-exchangeable, non-transferable, non-assignable and non-redeemable for cash and/or any other items.
6. To be eligible for the Promotion:
 - (a) The Eligible Customer's Dash Balance must be and remain valid, and must not for any reason be terminated and/or suspended, during the Promotion Period; and
 - (b) The Eligible Customer must comply at all times with the terms and conditions governing the use of Dash, including, but not limited to, the Dash Terms and Conditions.
7. Singtel is not an agent of the Merchant supplying the Promotional Items. The Promotional Items shall be subject to such other terms and conditions as may be imposed by the Merchant, and you agree to be bound by such terms.

Singtel makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Promotional Items and assumes no liability or responsibility for the acts or omissions of the merchants and/or suppliers of the Promotional Items. Any dispute about the value, condition or performance of any of the Promotional Items is to be resolved directly with the relevant merchants and/or suppliers of the Promotional Items.
9. Unless otherwise stated, this Promotion is not valid with other promotions, privileges, discount cards and promotional vouchers, offers, discounts, rebates, vouchers, privileges reward stamps or promotions by the Merchant.
10. Singtel reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in its sole absolute discretion and without prior notice to you and without liability to any party.
